We are counsel to McLean's Mountain Wind Limited Partnership ("McLean's"), the Applicant in the above captioned matter. We are writing to you today with respect to the timing of the McLean's responses to Board Staff and intervenor interrogatories.

In Procedural Order No. 2, the Board adjusted the timeline for this proceeding with the result that Board Staff and intervenor interrogatories would be due by March 2, 2012 and responses from McLean's would be due by March 21, 2012.
