**NOTICE OF APPLICATIONS AND WRITTEN HEARING**

**The Applications**

Active Energy Corp. has applied to the Ontario Energy Board for renewal of its Gas Marketer licence. The granting of this licence would enable the applicant to continue to market natural gas in Ontario.

Active Energy Inc. has applied to the Board for renewal of its Electricity Retailer Licence. The granting of this licence would enable the applicant to continue to retail electricity in Ontario.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. Due to the similar nature of the applications the applications will be combined into one proceeding pursuant to section 21(5) of the Act. The employee does not intend to provide for an award of costs when deciding the applications.

**How to see Active Energy Corp. and Active Energy Inc.'s Applications**

A copy of the non-confidential portion of the applications and related documents are available for inspection at the Board's office in Toronto. A copy can also be viewed at the applicants office at the address indicated below.

### **How to Participate in the Hearing**

The Board intends to proceed with these applications by way of written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing for these applications, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by **April 4, 2012**.

Any parties who wish information and material from the applicant that is in addition to the applicant's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before **April 11, 2012**. Where possible, the questions should specifically reference the pre-filed evidence. The applicant shall file with the Board complete responses to the interrogatories and deliver them to any interested parties in the proceeding no later than **April 25, 2012**.

Anyone who wishes to make a submission on the applications must file that written submission with the Board and deliver it to the applicant by **May 9, 2012**. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submission by **May 23, 2012**. All written submissions will be available for viewing at the Board's offices and will be placed on the Board's website.

If the written submission is from a private citizen (i.e., not a lawyer representing a client, not a consultant representing a client or organization, not an individual in an organization that represents the interests of consumers or other groups, and not an individual from a regulated entity), before placing the written submission on the public record, the Board will remove any personal (i.e., not business) contact information from the written submission (i.e., the address, telephone number and email address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.

**How to File Documents with the Board**

You must forward two paper copies, and if possible, an electronic copy in PDF format of your written submission to the Board and one copy to the applicant. All submissions must file number EB-2012-0044 and EB-2012-0045 and clearly state the sender's name, postal address, telephone number and email address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
