I am responding to a letter dated April 3, 2012 from Kristyn Annis of McCarthy Tetrault LLP ("McCarthy") concerning the Board's Decision and Order on Costs Awards of March 29, 2012 (the "Cost Decision").

In the letter, McCarthy on behalf of GRWLP asked the Board to "defer" the Costs Decision already made and released.

For the Board's information, my office served my letter of March 1, 2012 attaching the costs claim of Six Nations Council in the following manner:

(a) on March 2, 2012 by email at 2:37 p.m. to the Board Secretary copied to Mr. George Vegh of McCarthy as counsel of record for GRWLP (see Schedule 1 attached to this letter); and

(b) by electronic submission via the RESS system (see Schedule 2 attached confirming the Board's receipt dated March 2, 2012 at 3:16 pm confirming the e-filing and providing the reference number 15970 as confirmation of receipt).

Arrangements were also made for the delivery of the original copy of the Six Nations costs claim to the Board.

Contrary to the McCarthy letter of April 3, 2012, the Board's Motion Decision and Order of February 23, 2012 at page 13, paragraph 1 did not require delivery of the costs claim to all of the intervenors or even by the filing through the RESS. I have trouble imagining what interest the intervenors would have in the Six Nations costs claim from GRWLP. Nonetheless, the costs claim was in fact filed through the RESS as demonstrated by schedule 2 attached.

The McCarthy firm (Mr. G. Vegh, counsel of record for GRWLP), received the claim on March 2, 2012 by mail.

I also note that the McCarthy letter does not say that Mr. Vegh of McCarthy did not receive the Six Nations costs claim sent by email to Mr. Vegh on March 2, 2012. It was apparent from the email to the Board Secretary that it was copied only to legal counsel for GRWLP.

It seems likely that counsel to GRWLP and their client would have been aware of the deadline for responding to the Six Nations costs claim set out in the Board's Order of February 23, 2012.

It also seems likely that experienced legal counsel for GRWLP would have been in communication with their client, GRWLP, after receipt of the cost claim and before the response deadline. The McCarthy letter does not say that they did not seek instructions from their client.

It appears from the McCarthy letter of April 3, 2012 that GRWLP's prime concern was to ensure that all costs claimed were "appropriately assigned to the leave to construct hearing."

The Board will be aware that after the deadline for objections to the costs claim had passed, I was contacted by a Board staff person (Christiane Wong) for copies of Blakes dockets and disbursements related to the costs claim in order that they could be reviewed. Those were forwarded to the Board by a law clerk at Blakes.

It is presumed that the Board's analyst already carefully reviewed those dockets to verify that those were "appropriately assigned to the leave to construct hearing" and therefore properly claimed.
