**Re: Decision and Order on Cost Awards, March 29, 2012
Grand Renewable Wind LP ("GRWLP") proceeding (EB-2011-0063)**

The Board received a letter dated April 3, 2012 from GRWLP's counsel requesting that the Board defer its Cost Decision until GRWLP had an opportunity to respond to the cost claim by Six Nations Council.

The Board also received a response from the Six Nations Council dated April 9, 2012, and another letter from GRWLP dated April 11, 2012.

The Board issued its final order on cost claims on March 29, 2012. This was the final order in the EB-2011-0063 proceeding. Absent an appeal, the Board can only amend a decision or order through a motion to review pursuant to Rules 42-45 of the Board's *Rules of Practice and Procedure*. Although GRWLP has not yet formally asked the Board to amend its decision, presumably it will do so to the extent that any permitted review of Six Nations Council's cost claim reveals costs that GRWLP feels it should not have to pay. It is therefore the Board's view that any reconsideration of the costs order should be conducted through the framework of a motion to review.

The Board notes that according to section 42.03 of the *Rules of Practice and Procedure*, the April 3rd letter falls within the 20 calendar days of the March 29 date

of the Decision and Order on Cost Awards. The Board directs that, to the extent GRWLP intends to pursue this matter, it shall file a formal motion in accordance with Part VII of the *Rules of Practice and Procedure* within 14 calendar days.
