**NOTICE OF APPLICATION AND HEARING  
AND  
PROCEDURAL ORDER No. 1  
April 26, 2012**

Centre Wellington Hydro Ltd. ("CWHL") applied to the Ontario Energy Board (the "Board") for approval to dispose of the balance in Account 1562, Deferred Payments in Lieu of Taxes ("Account 1562") over a two-year period. The Application was filed on April 2, 2012 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). The Board has assigned the application file number EB-2012-0052.

CWHL originally included the request to dispose of Account 1562 in its 2012 IRM application (EB-2011-0160) filed on September 29, 2011. The Board determined that the evidence supporting the disposition of Account 1562 was not consistent with the various decisions made in the course of the Combined PILS proceeding (EB-2008-0381). The Board decided not to hear the disposition of Account 1562 as part of CWHL's 2012 IRM application and directed CWHL to address this matter in a stand-alone application to be filed no later than April 1, 2012. The current application is in response to that direction.

Since public notice has already been given in CWHL's 2012 IRM application regarding the disposition of Account 1562, the Board grants intervenor status and cost eligibility to

the intervenors of record in CWHL's 2012 IRM proceeding. The Board notes that the Vulnerable Energy Consumers Coalition ("VECC") and School Energy Coalition ("SEC") were granted intervenor and cost eligibility status in the IRM proceeding.

In the IRM proceeding, no letters of comment were received in respect to the disposition of Account 1562 nor were any objections raised with the Board's intention to proceed with the matter by way of a written hearing.

The Board will proceed with the review of this application by way of written interrogatories, to be followed by written submissions. Please note that further procedural orders may be issued from time to time.

#### **THE BOARD ORDERS THAT:**

1. VECC, SEC and Board staff wishing information and material from CWHL that is in addition to the evidence filed with the Board and that is relevant to the hearing shall request it by written interrogatories filed with the Board and delivered to CWHL on or before **May 11, 2012**.
2. CWHL shall file with the Board complete responses to the interrogatories and deliver them to VECC and SEC no later than **May 25, 2012**.
3. Board staff may file a written final submission with the Board and deliver it to CWHL, VECC and SEC no later than **June 8, 2012**.
4. VECC and SEC may file a written final submission with the Board and deliver it to CWHL no later than **June 13, 2012**.
5. CWHL may file a written reply submission and deliver it to VECC and SEC no later than **June 22, 2012**.

All filings to the Board must quote file number EB-2012-0052, be made through the Board's web portal at [www.errr.ontarioenergyboard.ca](http://www.errr.ontarioenergyboard.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties shall use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at

[www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If the web portal is not available, parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
