I enclose for your reference copies of my correspondence with Tribute Resources Inc. ("Tribute") wherein my office has requested on numerous occasions, the Application materials from Tribute (see letters from my office dated September 6, 2011 and December 12, 2011 and letter from Tribute dated December 15, 2011).

To date we have not received any materials.

My client is not in a position to provide comments on the Draft Issues List by May 7, 2012, as ordered. My client has been requesting materials from Tribute for 8 months to no avail. I would respectfully request that the deadlines contained in Procedural Order No. 1 be extended to a date which is not earlier than 60 days from the date on which Tribute provides the requested Application materials.

As you will note, in the December 15, 2011 letter attached, Tribute indicated that it had made the conscious decision not to send out materials until the dust settles and until it had evaluated whether it would be proceeding with these applications.


