FINAL RATE ORDER May 1, 2012

Introduction

Orillia Power Distribution Corp. ("Orillia"), a licensed distributor of electricity, filed an application with the Ontario Energy Board (the "Board") on October 31, 2011, under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Orillia charges for electricity distribution, to be effective May 1, 2012.

In its Decision and Order on the Application issued on April 19, 2012, the Board ordered Orillia to review the draft Tariff of Rates and Charges and to file with the Board a written confirmation assessing the completeness and accuracy of the draft Tariff of Rates and Charges, or provide a detailed explanation of any inaccuracies or missing information, within seven calendar days of the date of the Decision and Order.

On April 25, 2012, Orillia filed a letter confirming the completeness and accuracy of the draft Tariff of Rates and Charges with the exception of two areas. Orillia requested that the Board update the header for the Standby Power service classification to include the words "approved on an interim basis." Orillia also requested that the Board correct the monthly service charge for the Unmetered Scattered Load class from \$10.01 to \$10.10 to reflect the correct service charge in its rate model.

The Board accepts Orillia's proposed changes.

THE BOARD ORDERS THAT:

 The Tariff of Rates and Charges set out in Appendix A of this Order will become final, except for the stand by rates which remain interim, effective May 1, 2012, and will apply to electricity consumed or estimated to have been consumed on and after May 1, 2012. Orillia shall notify its customers of the rate changes no later than with the first bill reflecting the new rates.
