**IN THE MATTER OF** the *Ontario Energy Board Act 1998*, S.O.1998, c.15, (Schedule B);

**AND IN THE MATTER OF** an Application by Enbridge Gas Distribution Inc. to the Ministry of Natural Resources for a license to drill a total of four wells in the existing Kimball-Colinville Designated Storage Area.

### PROCEDURAL ORDER NO. 1 May 3, 2012

Enbridge Gas Distribution Inc (the "Applicant" or "Enbridge") filed an application dated February 14, 2012 with the Minister of Natural Resources for four well drilling licences in the Kimball-Colinville designated storage area.

.These applications were referred to the Ontario Energy Board (the "Board") by the Minister of Natural Resources on February 28, 2012, pursuant to section 40 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (schedule B).

On March 12, 2012 the Board issued a Notice of Application (the "Notice") and Letter of Direction. The Notice was served and published as directed by the Board.

The Board received requests for intervenor status from the Ministry of Natural Resources ("MNR") and from Union Gas Limited ("Union"). No one made a request for eligibility for cost awards.

On April 18, 2012, the Board granted Intervenor status to MNR and Union. Enbridge did not object.

The Board indicated, in the Notice, that the matter would proceed as a written hearing. Union expressed a preference for a written hearing while MNR took no postion.

This Procedural Order sets out the timeline for the proceeding including filing of interrogatories, responses to these interrogatories, written submissions by Board staff and Intervenors, and Enbridge's reply submissions.

The Board considers it necessary to make provision for the following procedural matters. The Board may issue further procedural orders from time to time.

### THE BOARD ORDERS THAT:

- 1. Intervenors and Board staff who wish information and material from Enbridge that is in addition to the evidence filed with the Board, and that is relevant to the proceeding, shall request it by written interrogatories filed with the Board and delivered to all parties no later than May 11, 2012. All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.
- 2. Enbridge shall, no later than **May 21, 2012** file with the Board and deliver to all intervenors, a complete response to each of the interrogatories.
- 3. Board staff and intervenors shall file their written submissions, if any, with the Board, and deliver it to Enbridge and other intervenors, by **May 31, 2012**.
- 4. If Enbridge wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors by **June 11, 2012**.

All filings to the Board must quote file number **EB-2012-0060** and must be made through the Board's web portal at <a href="www.errr.ontarioenergyboard.ca">www.errr.ontarioenergyboard.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.

Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required.
