### CIS/Billing System Implementation Report

### For Quarter 1 (January to March) 2012

### Status of the Project:

The CIS/Billing system implementation progressed well and the go-live date was May 9, 2011.

### Capabilities/Functionality of the New Billing System:

To date, we have not discovered any significant capability/functionality limitation with the Harris NorthStar system that has been implemented.

#### Regulatory Impact:

In the Board's Decision, the revenue allocated to our CIS was contingent upon the system being implemented prior to December 31, 2010.

In accordance with the Board's Decision, the revenue requirement impact plus carrying charges have been recorded in Account 2425, Other Deferred Credits, Sub-account: Over-Recovery of Capital Expenditures. As of March 31, 2012 the balance in this account is a debit, receivable balance \$103,746 as per the attached spreadsheet.
