NOTICE OF WRITTEN HEARING AND PROCEDURAL ORDER NO. 1

Application by Orangeville Hydro Limited for a Service Area Amendment

The Application

Orangeville Hydro Limited ("OHL") filed an application with the Ontario Energy Board under section 74 of the *Ontario Energy Board Act, 1998* for an order of the Board to amend OHL's licensed service area in Schedule 1 of its electricity distribution licence ED-2002-0500.

The application will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding this application.

This service area amendment is sought by OHL in order to expand its distribution service area to include specific lands currently located in Hydro One Networks Inc.'s ("Hydro One") licensed service area. The lands are described as Part of Lot 30, Concession 2, Geographic Township of East Luther, in the County of Dufferin. OHL wishes to supply and provide electricity distribution services to a proposed residential subdivision which is being developed by Thomasfield Homes Limited in the proposed amendment area.

Written Hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. The Board deems the parties directly affected by this application and listed in Appendix "A" to this Notice as intervenors in this proceeding.

THE BOARD THEREFORE ORDERS THAT

- The applicant shall immediately serve a copy of this Notice of Written Hearing and Procedural Order No. 1 on the intervenors listed in Appendix "A" and, to the extent that it has not already done so, the applicant shall immediately provide a copy of the application to the intervenors listed in Appendix "A", together with a copy of all other materials filed by the applicant in this proceeding. The applicant shall provide proof of service of the Notice and other materials to the Board by way of affidavit.
- 2. If a party objects to a written hearing in this matter, the party must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant on or before June 5, 2012.
- 3. Intervenors and Board staff who wish information and material from the applicant that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before June 11, 2012.
- 4. The applicant shall file complete responses to the interrogatories with the Board and deliver them to all intervenors on or before June 25, 2012.
- 5. Intervenors and Board staff who wish to submit evidence regarding the application must file that evidence with the Board and deliver it to the applicant and all intervenors on or before July 6, 2012.
- 6. Any party (intervenors, Board staff or the applicant) who wishes information and material from a party who submitted evidence that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the party who submitted the evidence on or before July 20, 2012.
- 7. Responses to interrogatories on intervenor and/or Board staff evidence shall be filed with the Board and delivered to all intervenors on or before August 2, 2011.
- 8. If intervenors and/or Board staff wish to file a written submission, the written submission must be filed with the Board and delivered to the applicant on or before August 15, 2012.

9. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all intervenors on or before August 29, 2012.

All filings to the Board must quote file number EB-2012-0181, be made through the Board's web portal at <u>www.errr.ontarioenergyboard.ca</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and email address. If the web portal is not available you may email your document to the address below.
