Independent Electricity System Operator Smart Metering Charge:

The Independent Electricity System Operator (IESO) is managing the development of the meter data management/repository to collect, manage, store and retrieve information related to the metering of customers' use of electricity in Ontario. The IESO has applied, EB-2012-0100, to the Ontario Energy Board (OEB) for approval of a Smart Metering Charge (SMC) of \$0.806 per Residential and General Service < 50 kW customer per month for the period July 1, 2012 to December 31, 2017. The OEB has commenced a proceeding on its own motion to determine the appropriate recovery and allocation of the SMC.
