> FINAL RATE ORDER June 14, 2012

Introduction

Orangeville Hydro Limited ("Orangeville Hydro"), a licensed distributor of electricity, filed an application (the "Application") with the Ontario Energy Board (the "Board") on January 31, 2012 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Orangeville charges for electricity distribution, to be effective May 1, 2012.

Orangeville sought Board approval for the disposition and recovery of costs related to smart meter deployment, offset by Smart Meter Funding Adder ("SMFA") revenues collected from May 1, 2006 to April 30, 2012. Orangeville requested approval of proposed Smart Meter Disposition Riders ("SMDRs") and Smart Meter Incremental Revenue Requirement Rate Riders ("SMIRRs") effective May 1, 2012.

In its Decision and Order on the Application issued on May 24, 2012, the Board ordered Orangeville Hydro to file with the Board a draft Rate Order attaching a proposed Tariff of Rates and Charges reflecting the Board's findings, within 7 days of the date of the Decision and Order. The draft Rate Order was also to include customer rate impacts and detailed supporting information showing the calculation of the final rates.

On May 30, 2012, Orangeville Hydro filed revised models and a proposed Tariff of Rates and Charges. On June 5, 2012, Board staff filed a letter indicating that it had reviewed the material submitted by Orangeville Hydro and had no comments. VECC did not submit any comments on the material filed.

The Board has reviewed the information provided by Orangeville Hydro and the proposed Tariff of Rates and Charges. The Board is satisfied that the Tariff of Rates and Charges accurately reflects the Board's Decision.

THE BOARD ORDERS THAT:

 The revised Tariff of Rates and Charges set out in Appendix A of this Order will become final effective June 1, 2012 and will apply to electricity consumed or estimated to have been consumed on and after June 1, 2012. Orangeville Hydro shall notify its customers of the rate changes no later than with the first bill reflecting the new rates.

UNMETERED SCATTERED LOAD SERVICE CLASSIFICATION

This classification refers to an account taking electricity at 750 volts or less whose average monthly maximum demand is less than, or is forecast to be less than, 50 kW and the consumption is unmetered. Such connections include cable TV power packs, bus shelters, telephone booths, traffic lights, railway crossings, etc. The level of the consumption will be agreed to by the distributor and the customer, based on detailed manufacturer information/documentation with regard to electrical consumption of the unmetered load or periodic monitoring of actual consumption.
