IN THE MATTER OF the *Ontario Energy Board Act,* 1998, S.O. 1998, c. 15, (Schedule B);

AND IN THE MATTER OF an application by Wellington North Power Inc. for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2012.

PROCEDURAL ORDER NO. 2

Wellington North Power Inc. ("WNP") applied to the Ontario Energy Board for permission to increase its delivery charges beginning May 1, 2012. The application was filed on April 13, 2012 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (Schedule B). The Board assigned the application File Number EB-2011-0249.

The Board issued Procedural Order No. 1 dated May 24, 2012 in which the Board established dates for the filing of written interrogatories and written submissions.

In correspondence dated June 22, 2012, WNP notified the Board that it was unable to provide its responses to parties' interrogatories within the specified timelines due to the implementation of a new financial system which does not contain the level of historical detail required to provide satisfactory responses. WNP requested an extension of the date to file responses to interrogatories to June 28, 2012.

The Board grants the extension requested by WNP and hereby cancels the filing dates established in Procedural Order No. 1. The Board has established new dates for the filing of interrogatory responses as set out below.

The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

1. WNP shall file with the Board complete responses to interrogatories and deliver them to all intervenors no later than June 28, 2012.

All filings to the Board must quote the file number, EB-2011-0249, be made through the Board's web portal at https://www.errr.ontarioenergyboard.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at http://www.ontarioenergyboard.ca/OEB/Industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
