PROCEDURAL ORDER No. 2
July 6, 2012

Orangeville Hydro Limited ("OHL") filed an application with the Ontario Energy Board on March 23, 2011, under section 74 of the *Ontario Energy Board Act, 1998* to amend Schedule 1 of its licensed service area under its electricity distribution licence ED-2002-0500. OHL filed supplementary information on May 10, 2012.

The Board issued a Notice of Written Hearing and Procedural Order No.1 on May 16, 2012.

On June 5, 2012, Hydro One Networks Inc. ("HONI") filed a letter with the Board stating that it plans to contest the service area amendment application filed by OHL. In accordance with the Board's Procedural Order No. 1 timelines on June 11, 2012, Board staff and HONI filed their respective interrogatories. OHL filed its interrogatory responses on June 25, 2011.

On June 27, 2012, HONI filed a Notice of Motion for an order of the Board requiring OHL to provide responses to certain interrogatories filed by HONI on June 11, 2012. HONI also requested that the Board extend the date by which HONI and Board staff must submit evidence regarding the application to a date that is 10 days after the date the Board issues a Decision and Order on the Motion or to a date that is 10 days after the applicant has complied with any Decision and Order that may be made by the Board granting any portion of the relief requested in this Notice of Motion, whichever date is later.

On June 29, 2012, OHL responded to HONI's Notice of Motion indicating that it has "provided sufficient information in its responses to the interrogatories referred to in the Notice of Motion and requested that the Board dispense with the motion." As well, OHL is requesting that in the event that the Board decides that a hearing is required, that the Board schedule a quick hearing to accommodate the proposed timing for the development of the subject property.

The Board will hear the motion filed by HONI in writing. The Board notes that the hearing of the motion will result in a revision to the dates for submissions and reply submissions that were set in Procedural Order No. 1.

This procedural order may be amended, and further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. Hydro One Networks Inc. shall file any additional written submission on its motion with the Board and copy all other parties in this proceeding by **July 16, 2012**.
2. Board staff and intervenors who wish to file a written submission in relation to the motion filed by Hydro One Networks Inc. shall file their written submissions with the Board and copy all other parties in this proceeding by **July 23, 2012**.
3. OHL shall file any written submissions on the motion with the Board and copy all other parties in this proceeding by **July 30, 2012**.
4. Hydro One Networks Inc. shall file any written reply submission with the Board and copy all parties in this proceeding by **August 7, 2012**.
5. **Paragraphs 5, 6, 7, 8 and 9** of Procedural Order No. 1 are hereby rescinded. New dates for submissions and any reply submissions on the merits of the application will be set at a future date.

All filings to the Board must quote file number EB-2012-0181, be made through the Board's web portal at www.errr.ontarioenergyboard.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly

state the sender's name, postal address and telephone number, fax number and email address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
