NOTICE OF APPLICATION

GAS FRANCHISE APPROVAL FOR THE TOWN OF AURORA

On July 3, 2012, Enbridge Gas Distribution Inc. ("Enbridge") filed an application with the Ontario Energy Board under the *Municipal Franchises Act,* R.S.O. 1990, c. M55 as amended (the "Act"). The application is for an order of the Board renewing Enbridge's right to operate works and add to works for the distribution of gas in the Town of Aurora ("Town") for a period of 20 years. The Board has assigned file number EB-2012-0306 to the application.

Enbridge has a franchise agreement with the Town which expires on December 17, 2012.

Enbridge holds a Certificate of Public Convenience and Necessity to operate works and add to works for the distribution of gas in the geographical area comprising the Town (F.B.C. 78).

The application will be decided by the Manager, Natural Gas Applications, who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). The Manager, Natural Gas Applications, does not intend to provide for an award of costs when deciding the application.

<u>Comment</u>

If you wish to give your opinion on the proceeding you are invited to send a written letter of comment to the Board no later than **30 days** after the publication or service date of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the Board. All letters of comment will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letter of comment on the public record, the Board will remove any personal (i.e., not business) contact information from the letter of comment (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter of comment to the Board Secretary at the address below, and reference file number **EB-2012-0306** at the top of your letter.

<u>Observe</u>

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or service date of this notice. All letters requesting observer status will become part of the public record, which means that the letters can be seen at the Board's offices and will be placed on the Board's website. Before placing the request for observer status on the public record, the Board will remove any personal (i.e., not business) contact information from the request (i.e., the address, fax number, phone number, and e-mail address of an individual). However, the name of the individual and the content of the request for observer status will become part of the public record.

<u>Intervene</u>

If you wish to actively participate in the proceeding (e.g. submit questions, file argument), you may request intervenor status from the Board, no later than **10 days** after the publication or service date of this notice.
