The Ontario Energy Board (the "Board") has now issued its Notice of Application and Hearing (the "Notice") with respect to the above application.

You are directed:

1. To immediately arrange for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one issue of the *Globe & Mail* and in one issue of the weekly English language newspaper having the highest circulation, according to the best information available, in or servicing Great Lakes Power Transmission LP's ("GLPT") service area;
2. To immediately arrange for the enclosed French version of the Notice headed with the Ontario Government logo and the words "Commission de l'Énergie de l'Ontario", to be published in one issue of *Le Droit* and in one issue of the weekly French language newspaper having the highest circulation, according to the best information available, in or servicing the GLPT service area;

To immediately have the Notice served on:

- all licensed transmitters;
- all local distribution companies that GLPT serves;
- all large users that GLPT serves;
- the Independent Electricity System Operator;
- Ontario Power Authority;
- Association Of Power Producers in Ontario;
- the Consumers Council of Canada;
- the Vulnerable Energy Consumers Coalition;
- the Association of Major Power Consumers of Ontario;
- Energy Probe;
- Pollution Probe;
- the School Energy Coalition; and
- the Electricity Distributors Association.

3. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter, with the relevant Notices, Application, and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.;
4. To make a copy of the application and related evidence available for public review at GLPT 's office and to post all such documents on GLPT's web site; and
5. To provide a copy of the application and evidence to anyone requesting the material.
