AND IN THE MATTER OF an Application by Enbridge Gas Distribution Inc. for an Order or Orders approving or fixing just and reasonable rates and other charges for the sale, distribution, transmission and storage of gas commencing January 1, 2013.

PROCEDURAL ORDER NO. 3 August 2, 2012

Enbridge Gas Distribution Inc. ("Enbridge") filed an application on January 31, 2012 with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Schedule B for an Order or Orders approving or fixing just and reasonable rates and other charges for the sale, distribution, transmission and storage of gas commencing January 1, 2013. The Board assigned file number EB-2011-0354 to the application and issued a Notice of Application dated March 2, 2012 (the "Notice"). The application was filed on the basis of US Generally Accepted Accounting Principles ("USGAAP").

The Board received a letter dated July 27, 2012 from the Vulnerable Energy Consumers Coalition ("VECC"), an intervenor in the proceeding, requesting a three working-day extension to the date for filing intervenor evidence. Procedural Order No. 2 had established the date as August 10, 2012 and VECC requested that the date be extended to August 15, 2012. The Board finds that VECC's request is reasonable and will also extend the related interrogatory process by three working days.

THE BOARD ORDERS THAT:

- Board staff and intervenors who wish to present evidence shall file that evidence with the Board and deliver it to Enbridge and all intervenors on or before August 15, 2012.
- If any intervenor, Board staff or Enbridge requires additional information related to any intervenor evidence, they shall request it by written interrogatories filed with the Board and delivered to Enbridge and all intervenors on or before August 22, 2012.
- Responses to the interrogatories on intervenor evidence shall be filed with the Board and delivered to Enbridge and all intervenors on or before August 29, 2012.

All filings to the Board must quote file number **EB-2011-0354**, be made through the Board's web portal at <u>www.errr.ontarioenergyboard.ca</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address.

All filing shall use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available the document may be emailed to the <u>BoardSec@ontarioenergyboard.ca</u>. Persons who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Persons who do not have computer access are required to file seven paper copies. If a document has been submitted through the Board's web portal an e-mail is not required.
