AND IN THE MATTER OF an application by Ontario Power
Generation Inc. pursuant to section 78.1 of the *Ontario
Energy Board Act, 1998* for an Order or Orders determining
payment amounts for the output of certain of its generating
facilities.

PROCEDURAL ORDER NO. 3

The Ontario Energy Board (the “Board”) received an application from Ontario Power Generation Inc. (“OPG” or the “applicant”) on November 30, 2007, under section 78.1 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B (the “Act”), seeking approval for increases in payment amounts for the output of certain of its generating facilities, to be effective April 1, 2008. The Board has assigned the application file number EB-2007-0905.

On March 20, 2008 the Board issued Procedural Order No. 2 which revised the schedule for the proceeding. That procedural order fixed the date for filing of intervenor evidence as April 21, 2008. On April 7, 2008 the Consumers Council of Canada (“CCC”) asked for an extension of that filing date due to the unexpected unavailability of its consultant. The Board grants the request. All other dates fixed in Procedural Order No. 2 remain unchanged.

Further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. CCC shall file its evidence with the Board, and deliver it to all other parties, by Wednesday April 30, 2008.

2. Intervenor, Board staff or the applicant who wish information and material from evidence filed by CCC that is in addition to the evidence filed with the Board shall request it by written interrogatories filed with the Board and delivered to CCC on or before Tuesday May 6, 2008.
3. CCC shall file with the Board complete responses to the interrogatories and deliver them to all other parties no later than Monday May 12, 2008.

All filings to the Board must quote file number EB-2007-0905, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format filed through the Board's web portal at www.errr.oeb.gov.on.ca. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may e-mail your document to Boardsec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary, and be received no later than **4:45 p.m.** on the required date.
