As directed in the Ontario Energy Board's March 17, 2008 Decision on the matter of Kingston Electricity Distribution Limited's ("KEDL") 2008 Electrical Distribution Rates Adjustments, please find enclosed two hard copies of KEDL's 2008 Draft Rate Order and Appendix containing proposed 2008 Tariff of Rates and Charges, an electronic copy of the 2008 Draft Rate Order and proposed 2008 Tariff of Rates and Charges in Word format, and an electronic copy of the adjusted supporting rate model (spreadsheet) in Excel format. As well this 2008 Draft Rate Order and proposed 2008 Tariff of Rates and Charges have now been submitted through the RESS filing system.

As directed in the Decision, KEDL has reviewed the rate model (spreadsheet) provided by the Board that reflects the price cap adjustments applied by the Board to distribution rates (fixed and variable charges) uniformly across all customer classes and confirms its completeness and accuracy specific to the price cap index adjustments.

KEDL has adjusted the rate model (spreadsheet) provided by the Board, as per the Decision, to include the changes to the Retail Transmission Service Rates for all rate classes.

In the 2008 Draft Rate Order further detail may be found regarding KEDL's review of the Board's applied price cap index adjustment, KEDL's changes to the Board's rate model (spreadsheet) specific to the Retail Transmission Service Rates adjustments, and necessary adjustments to the filed 2007 Tariff of Rates and Charges that KEDL has

made so as to produce a new proposed 2008 Tariff of Rates and Charges are clearly identified and explained.

In summary, the 2008 Draft Rate Order and proposed 2008 Tariff of Rates and Charges submitted by KEDL reflects the Board's Decision on adjustments and the changes the Board has directed KEDL to include in KEDL's 2008 Draft Rate Order. As President and Chief Executive Officer of Kingston Electricity Distribution Limited, I request that this submission be approved as filed.
