**Re: Enbridge Gas Distribution Inc – OEB EB-2011-0354  
Request for Late Intervenor Status by Vista Credit Corp.**

We are writing to request late intervenor status in the above referenced proceeding.

Vista Credit Corp is a leading provider of HVAC rental and financing that was established in 2002. Vista Credit provides its services to consumers through a dealer network of small and medium size contractors. Vista Credit's offering allows small and medium size HVAC contractors to compete with much larger industry players, by providing a financial offering and access to Enbridge Gas Distribution billing services. Vista Credit has been a participant in the Open Bill Agreement since 2008.

Vista Credit's interest in this proceeding is strictly related to the Open Bill Agreement. Vista Credit fully accepts the evidence presented to date and does not intend to present any new evidence to the hearing. However, as a direct participant to the Open Bill Agreement, some of the proposed changes by Enbridge Gas Distribution may have a material impact on our business operations.

Vista Credit received first notice of Enbridge Gas Distribution's request to amend the terms of the Open Bill Agreement in a letter dated June 28<sup>th</sup>, 2012. The letter indicated that proposed changes to the Open Bill Agreement could be viewed via a web link to the OEB site. It invited questions to be submitted by July 6, 2012. Vista Credit submitted a number of questions regarding the proposed changes. On August 10<sup>th</sup>, 2012, Vista Credit received an invitation to attend a meeting on August 28<sup>th</sup>, 2012, of all open billers regarding proposed changes to the Open Bill Agreement. The outcome of the August 28<sup>th</sup> meeting first brought it to the attention of Vista Credit, that it would be required to request late intervenor status in order to address substantial changes proposed by Enbridge Gas Distribution in the Open Bill Agreement.

Vista Credit would not seek any award of costs.


