PROCEDURAL ORDER NO. 1
September 11, 2012

Enbridge Gas Distribution Inc. (“Enbridge”) filed an application with the Ontario Energy Board (the “Board”) on June 28, 2012 under sections 90 and 97 of the *Ontario Energy Board Act, 1998*, for an order granting Enbridge leave to construct approximately 18.8 kilometres (“km”) of Nominal Pipe Size 24 (“NPS 24”) Extra High Pressure (“XHP”) steel pipeline (the “proposed pipeline”) to reinforce the existing natural gas delivery system in the Ottawa, Ontario area. Enbridge is also seeking an order approving the form of easement agreements provided in the application. The Board has assigned the application file number EB-2012-0099.

The Board issued a Notice of Application (the “Notice”) dated July 26, 2012.

No party has requested intervenor status in this proceeding.

Observer status was requested by Carleton Condominium Corporation #51 (“Carlton Condominium”). The Board grants observer status to Carlton Condominium.

On August 22 and 30, 2012, the Board received letters of comment from CastleGlenn Consultants Inc. and the City of Ottawa, respectively.

The Board considers it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

1. Board staff may file written interrogatories with the Board and serve them on Enbridge on or before **September 24, 2012**.
2. Enbridge shall file complete interrogatory responses with the Board on or before **October 5, 2012**.
3. Board staff may file a written submission with the Board and serve it on Enbridge on or before **October 19, 2012**.
4. Enbridge may file a reply submission with the Board on or before **October 26, 2012**.

All filings to the Board must quote file numbers EB-2012-0099 be made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.

If the web portal is not available you may email your document to the BoardSec@ontarioenergyboard.ca.
