**NOTICE OF INTENTION TO MAKE AN ORDER FOR REVOCATION OF A
LICENCE UNDER SECTION 112.4 OF THE *ONTARIO ENERGY BOARD
ACT, 1998***

CORRECTED

The Ontario Energy Board (the “Board”), on its own motion under section 112.2 of the *Ontario Energy Board Act, 1998* (the “Act”), intends to make an Order under section 112.4 of the Act to revoke electricity wholesaler licence EW-2008-0112 (the “Licence”) issued to Thunder Bay Fine Papers Inc. (“Thunder Bay”).

ALLEGATIONS OF NON-COMPLIANCE

It is alleged that Thunder Bay has contravened section 7.1 of the Licence by failing to pay the Board’s annual licence fee for the year 2010-2011.

PARTICULARS

The particulars in support of the allegations set out in this Notice are as follows.

On November 26, 2010, the Board issued invoice number 1011EW089 dated November 11, 2010 to Thunder Bay in the amount of \$800.00 covering the Board’s annual licence fee in respect of the Licence for 2010-2011.

The invoice referred to above was sent to the attention of Mr. Mark Neimi, the person designated by Thunder Bay as the primary contact with the Board on matters related to the Licence, at Thunder Bay Fine Papers Inc, 550 Shipyard Road, P.O. Box 10640, Thunder Bay, ON, P7B 6V1, being the address designated by Thunder Bay as the address for service on matters related to the Licence.

The Board has not received payment of the invoice referred to above.

Failure to pay all fees charged and amounts assessed by the Board is a contravention of an enforceable provision within the meaning of the Act; more specifically, it is a contravention of section 7.1 of the Licence.

THEREFORE TAKE NOTICE that Thunder Bay may request, within fifteen days after receiving this Notice, that the Board hold a hearing on these matters. If no request for hearing is made within this time period, the Board may proceed to make an Order revoking the Licence.

FURTHER TAKE NOTICE that if a hearing is requested, the Board is not bound by the above-noted enforcement action and has discretion, upon finding one or more contraventions of an enforceable provision, to make any order it deems appropriate under section 112.4 of the Act. Thunder Bay is entitled to be present at the hearing with or without counsel and to adduce evidence and make submissions. Should Thunder Bay fail to attend, the hearing may be conducted in its absence and Thunder Bay will not be entitled to any further notice in the proceeding.
