Energy Probe – Follow-up Questions from Technical Conference**

Further to the technical conference proceedings on September 6, 2012, below please find an additional question related to Issue C4: Is the Average Use forecast appropriate?

You will note that during the Technical Conference, at Page 208 of the Transcript, beginning at Line 16, a request was made to Enbridge as follows: ***“Please provide the 2013 forecast for the western region central weather zone, the northern region central weather zone, and the Niagara weather zone, both with and without the time variable included in the equation.”***

In response, Ms. Suarez informed me, starting at Line 3 on Page 209, that it already exists and provided directions to the Updated Evidence, Exhibit C2, Tab 2, Schedule 1, on Page 12. At Line 18 of Page 209, Ms. Suarez asked me: “Is that what you were looking for?” My reply was at Line 19, Page 209: “I think so. I will have to check with Randy...” In checking with Mr. Aiken, I find that I was misdirected; the information requested was not at that point of reference.

To be clear, I was asking for the 2013 forecast, not the equation specifications which are found in the material referenced. Energy Probe would appreciate Enbridge filing the information requested in advance of the Settlement Conference next week.
