**NOTICE OF APPLICATION AND
PROCEDURAL ORDER NO. 1**

Union Gas Limited ("Union Gas") filed an application with the Ontario Energy Board (the "Board") dated August 31, 2012, seeking approval for its 2013-2014 Large Volume Demand Side Management ("DSM") Plan.

The application has been filed pursuant to the Board's DSM Guidelines that were issued on June 30, 2011, as well as in accordance with the Union Gas Settlement Agreement, January 31, 2012 (EB-2011-0327) which was accepted by the Board on February 21, 2012. Union Gas is seeking approval of a Large Volume DSM Program budget of \$4.664M plus inflation in both 2013 and 2014. Union estimates the 2013 budget to be \$4.769M and the 2014 budget to be \$4.876M.

The Board has assigned file number EB-2012-0337 to this application.

Union Gas indicated that it has sent a copy of the application to the parties of its 2012-2014 DSM Plan proceeding (EB-2011-0327). The Board has determined that the following procedural steps are required. The Board may issue further procedural orders from time to time.

Intervenor Status and Cost Eligibility

The Board hereby grants both status as an intervenor and eligibility for a cost award to those parties who were approved as intervenors in EB-2011-0327 (list attached as Appendix A).

Intervene

Parties not part of EB-2011-0327 who wish to actively participate in this proceeding (e.g., submit questions, file argument), may request intervenor status from the Board no later than **10 days** after the publication or service date of this notice. Instructions for requesting intervenor status and cost eligibility are available on the Board's website at www.ontarioenergyboard.ca/participate. Everything an intervenor files with the Board, including the intervenor's name and contact information, will be placed on the public record, which can be seen at the Board's office and will be available on the Board's website.

1. Union Gas Limited shall immediately serve a copy of this Notice and its application on each member of its DSM Consultative.
2. Union Gas Limited shall immediately serve a copy of this Notice and its application to each participant in its most recent rates proceeding (EB-2011-0210).
3. Intervenors and Board staff who wish to seek further information from the applicant shall request it by written interrogatories filed with the Board and delivered to the intervenors and the applicant on or before **October 11, 2012**.
4. Union Gas Limited shall file complete responses to all interrogatories and deliver them to parties on or before **October 25, 2012**.
