On December 28, 2007, Market Hub Partners Management Inc. and AltaGas Ltd., on behalf of Sarnia Airport Storage Pool Limited Partnership, a limited partnership being formed under the laws of Ontario (the "Applicant") by respective subsidiaries of MHP Management Inc. and AltaGas Ltd., forwarded an Application for approval related to the development and operation of the Sarnia Airport Storage Pool Project. Procedural Order No. 1 for the proceeding was issued by the Board on April 4, 2008.

One schedule to the Application and four schedules to the Pre-filed Evidence have been updated to reflect the most current information. A summary of the updates to each schedule is shown below.

- 1) Schedule C, Application – Rev. 1  
Some names and addresses of property owners and/or interested parties, determined during service of the Notice of Application in accordance with the Letter of Direction, dated February 14, 2008, have been updated. This revision replaces the original Schedule C in its entirety.
- 2) Section 6.3.A through D, Pre-filed Evidence – Rev. 1  
Each Application for a Well Licence has been updated. There are no changes to any of the survey drawings. Each Application for a Well Licence is now uniquely identified A through D for easier reference. This revision replaces the original Schedule 6-3 in its entirety.
- 3) Section 6.7, Pre-filed Evidence – Rev. 1  
The property owner in the southwest corner of the map was incorrectly referenced as Ron & Wilma Hardick. Ron & Sharon Hardick are the property owners reflected on the revised Schedule 6-7. This revision replaces the original Schedule 6-7 in its entirety.
- 4) Section 6.9, Pre-filed Evidence – Rev. 1  
Based on the service of the Notice of Application in accordance with the Letter of Direction, dated February 14, 2008, some changes have been made to names of property owners and minor changes have been made to property boundaries in two (2) areas: i) Concession III, Lots 2 and 3, Peter Vokes property on Churchill Line (due to recent severances); and ii)

Concession VI, Lot 4, at the Jenny Kapteyn property (minor lot line adjustments). This revision replaces the original Schedule 6-9 in its entirety.

5) Section 8.1, Pre-filed Evidence

As noted in Section 8 - Environmental Matters of the Pre-filed Evidence, on page 40, at lines 879 to 881, Stantec has completed its letter update to the Environmental and Socio-Economic Impact Assessment. This update letter and its attachments can be placed in Schedule 8-1 of the Pre-filed Evidence.

Nine (9) copies of each of the revised schedules are enclosed. The Applicant has also forwarded one copy of each revised schedule to the registered Intervenor and Observers for the proceeding.
