NOTICE OF APPLICATION AND HEARING FOR ORDERS RELATED TO DEFERRAL AND VARIANCE ACCOUNTS AND THE ADOPTION OF USAAP FOR REGULATORY PURPOSES

Ontario Power Generation Inc.

Ontario Power Generation Inc. ("OPG") has applied to the Ontario Energy Board for an order or orders related to deferral and variance accounts, including disposition of balances as at December 31, 2012, and the adoption of the Generally Accepted Accounting Principles of the United States ("USGAAP") for regulatory accounting purposes. The application is pursuant to section 78.1 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c.15 (Schedule B). The Board has assigned the application file number EB-2012-0002.

OPG forecasts a deferral and variance account balance of \$1.3 billion at the end of 2012. Based on the forecast, OPG proposes to recover \$964 million in the two year period 2013-2014 with payment riders effective January 1, 2013. According to OPG, the monthly bill for a Residential customer who consumes 800 kWh per month will increase by about \$1.70. This increase, if approved, would be captured in the "electricity" component of a Residential customer's bill. This increase is separate from other potential changes in electricity bills that are not the subject of this application, such as changes to the "electricity" component related to other sources of supply, changes to the "delivery" component related to transmission and delivery charges, and other charges applied to the bill.
