### **PROCEDURAL ORDER NO. 1**

Natural Resource Gas (“NRG”) filed an Application on August 7, 2012 with the Ontario Energy Board (the “Board”) under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Sched. B, as amended, for an order of the Board approving or fixing rates for the distribution, transmission and storage of natural gas, effective October 1, 2012. The Board assigned file number EB-2012-0342 to the Application and issued a Notice of Application on September 12, 2012.

Intervenor status was requested by Union Gas Limited (“Union”) and the Vulnerable Energy Consumers Coalition (“VECC”). VECC applied for cost eligibility. NRG did not object to the request for cost eligibility.

The Board grants intervenor status to Union and VECC. A list of intervenors in this proceeding is attached as Appendix A to this Order. The Board has also determined that VECC will be eligible to apply for an award of costs under the Board’s *Practice Direction on Cost Awards*.

Observer status was requested by Enbridge Gas Distribution Inc. (“Enbridge”). The Board grants observer status to Enbridge.

The Board will now make provision for the following procedural matters.

Please be aware that further procedural orders may be issued from time to time.

Intervenor and Board staff who wish information and material from NRG that is in addition to the evidence filed with the Board, and that is relevant to this proceeding, shall request it by written interrogatories filed with the Board and delivered to NRG on or before **Monday, October 22, 2012**.
3. NRG shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than **Monday, November 5, 2012**.
