#### Statement of Interest

Energy Probe is a non-profit environmental and consumer organization which promotes economic efficiency in the use of resources. Energy Probe will be representing its residential customer supporters in Ontario, of which we have some number of thousands, and also representing a broader public interest concern with respect to the overall financial health and operational integrity of our utilities. Energy Probe will be intervening on issues which the Foundation believes to be in the public interest.

#### Intervention

Energy Probe intends to appear and participate in the hearing. Energy Probe expects to be a full-time intervenor and will be assisted by experts. Energy Probe was a funded intervenor in the Board's regulatory process to establish the methodology to be used to set the payment amounts, which underpin the subject of this proceeding, in the EB-2007-0905 Payment Amounts proceeding and in the EB-2010-0008 Payment Amounts proceeding.

Energy Probe intends to seek a cost award in this proceeding, and expects to intervene responsibly, cognizant of the Board's guidelines regarding cost awards.


