Re: Electricity Generation Licence EG-2011-0360 (RESOP) – Amendment for Name Change

Attention Board Secretary:

On August 22, 2012, Canadian Solar Solutions Inc. (CSSI) and Northstar Renewable Power Corp. (Northstar) completed a change of control transaction that resulted in Northstar acquiring 100 per cent of Canadian Solar I LP and its general partner, Canadian Solar I Inc. As part of the transaction, Northstar was required to change the name of both purchased entities. As of October 2, 2012, “Canadian Solar I LP” became “Stone Mills Solar Park LP” and “Canadian Solar I Inc.” became “Stone Mills Solar Park GP Inc.”. The details of this transaction are reflected in the organizational chart attached to this letter. Confirmation of the legal name change is reflected in the articles of amendment also attached hereto.

Further to this change of control transaction and subsequent name change, please consider this letter as a request to change the name to appear on the above referenced licence. The requested amendment is summarized in the following table:
