The Board has reviewed your application for an electricity generator licence. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Question 15. Key Individual Information indicates that you and Byron Thompson are officers of Peterborough Utilities Inc. Please inform the Board if you and Byron Thompson are also officers of Trent Energy Inc.
2. Your application stated that the acquisition of the generation facility from Trent University is in process. What is the planned date for the asset purchase agreement and when is the commercial transaction expected to close.
3. Please note that Trent University should be providing the Board with a written request to cancel electricity generation licence EG-2002-0336 with respect to the subject generation facility on close of the commercial transaction.

The Board also notes that there is some additional information typically asked for in an electricity generation licence application related to an acquisition. It includes the following:

- With reference to Hydro Electric Contract Initiative, Contract HCI-033, please let the Board know when the Assumption and Acknowledgement Agreement will be approved and file a copy of the Agreement with the Board when approved.

There is no expectation that this additional information is needed to begin the process of reviewing this application. However, by providing such information at the same time as the required information, the processing of this application can be expedited.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
