

We are counsel to Dufferin Wind Power Inc. ("Dufferin Wind"). In response to a request from Counsel to the Ontario Energy Board, we are hereby providing in confidence on behalf of Dufferin Wind a copy of the FIT Contract Assumption and Acknowledgement Agreement among Dufferin Wind, Farm Owned Power (Melancthon) Ltd. ("FOP") and the Ontario Power Authority (the "OPA"), dated June 2, 2011, pursuant to which the FIT Contract for the Dufferin Wind Farm was assigned from FOP to Dufferin Wind (the "Assignment Agreement").


Pursuant to Rule 10 of the Board's *Rules of Practice and Procedure*, Dufferin Wind hereby requests, for the reasons that follow, that the Assignment Agreement in its entirety be held in confidence by the Board.

Section 7 of the Assignment Agreement provides that the Assignment Agreement in its entirety constitutes Confidential Information pursuant to the underlying FIT Contract and is subject to Article 7 of Schedule 1 of the FIT Contract. In accordance with Article 7, Dufferin Wind has provided notice to the OPA of the request from Board Counsel for disclosure of the Assignment Agreement and the OPA has agreed to the Assignment Agreement being filed with the Board for the purpose requested. Nevertheless, to maintain the confidential and commercially sensitive nature of the information being provided and to ensure Dufferin Wind remains compliant with the terms of its FIT Contract, Dufferin Wind hereby requests that the Assignment Agreement be held in confidence.

As required by section 5.1.4 of the Board's Practice Direction on Confidential Filings, the document may be described in non-confidential terms as a FIT Contract Assumption and Acknowledgement Agreement among Dufferin Wind, Farm Owned Power (Melancthon) Ltd. and the Ontario Power Authority, dated June 2, 2011, pursuant to which the April 30, 2010 FIT Contract for the Dufferin Wind Farm was assigned from Farm Owned Power (Melancthon) Ltd. to Dufferin Wind.
