#### **PROCEDURAL ORDER NO. 4**

The Ontario Energy Board (the “Board”) received an application from Ontario Power Generation Inc. (“OPG” or the “applicant”) on November 30, 2007, under section 78.1 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B (the “Act”), seeking approval for increases in payment amounts for the output of certain of its generating facilities, to be effective April 1, 2008. The Board has assigned the application file number EB-2007-0905.

On March 20, 2008 the Board issued Procedural Order No. 2 which fixed the date for filing intervenor evidence as April 21, 2008. On April 17, 2008 the Board received letters from the Association of Major Power Consumers of Ontario (“AMPCO”) and Energy Probe asking for extensions of that filing date due to the delay in receiving all of the interrogatory responses from OPG. On April 18, 2008, Pollution Probe requested that this extension be provided to all intervenors. The Board will grant an extension to all intervenors. All other dates fixed in Procedural Order No. 2 remain unchanged, as do the dates established for the Consumers Council of Canada (“CCC”) in Procedural Order No. 3.

Further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. Intervenors (with the exception of CCC) or Board staff shall file their evidence with the Board, and deliver it to all other parties, by Thursday April 24, 2008.
2. Intervenors, Board staff or the applicant who wish information and material that is in addition to the evidence filed by intervenors (with the exception of CCC) or Board staff shall request it by written interrogatories filed with the Board and delivered to all intervenors on or before Thursday May 1, 2008.
3. Intervenors or Board staff (with the exception of CCC) shall file with the Board complete responses to the interrogatories and deliver them to all other parties no later than Friday May 9, 2008.

All filings to the Board must quote file number EB-2007-0905, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format filed through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca). Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available you may e-mail your document to [Boardsec@oeb.gov.on.ca](mailto:Boardsec@oeb.gov.on.ca). Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
