## **Board Staff Comments on Draft Rate Order**

On October 25, 2012, the Board issued its Decision and Order (the "Decision") on Veridian's disposition and recovery of costs related to smart meter deployment application. The Decision required Veridian to submit a draft Rate Order including a proposed Tariff of Rates and Charges within six days of the issuance of the Decision. Veridian submitted its draft Rate Order and proposed Tariff of Rates and Charges on October 29, 2012. On October 30, 2012 Veridian submitted an Excel spreadsheet (i.e. Appendix A) with the calculations of the SMDR and SMIRR rate riders.

Board staff agrees that Veridian has appropriately reflected the Board's findings in its draft Rate Order and proposed Tariff of Rates and Charges.

Board staff notes one exception to the proposed Tariff of Rates and Charges. It has come to the attention of Board staff that there is a typographical error in Veridian's current Board approved Tariff of Rates and Charges. In Veridian's 2012 rate application (EB-2011-0199), the Board approved a rate rider with a two year disposition period for Veridian's Group 1 Deferral and Variance Account balances, including Account 1521 Special Purpose Charge Assessment Variance Account for both Veridian's Main and Gravenhurst service areas. Board staff notes that the Rate Rider for Deferral/Variance Account Disposition (2012) and Rate Rider for Global Adjustment Sub-Account Disposition (2012) for all applicable rate classes in both service areas should have a sunset date of April 30, 2014 and not April 30, 2013.
