NOTICE OF APPLICATION AND NOTICE OF WRITTEN HEARING AIM SOP PHASE I LP, BY ITS GENERAL PARTNER AIM SOP PHASE I GP INC. APPLICATION FOR ELECTRICITY GENERATION LICENCE

AIM SOP Phase I LP, by its General Partner AIM SOP Phase I GP Inc. has filed an application with the Ontario Energy Board, dated April 7, 2008 under section 60 of the *Ontario Energy Board Act*, 1998. The applicant seeks an electricity generation licence as a Standard Offer Program participant. The applicant seeks to be the licensed owner and operator of the following facilities:

- Mohawk Point Wind Farm (Haldimand County);
- Frogmore Wind Farm (Norfolk County);
- Cultus Wind Farm (Norfolk County); and
- · Clear Creek II Wind Farm (Norfolk County).

AIM PowerGen Corporation, an affiliate of the applicant, is currently licensed to be owner and operator of the first three facilities listed above. If the Board grants the applicant's application, AIM PowerGen Corporation intends to apply for a licence amendment to remove these three facilities from its licence.

The granting of the licence will enable the applicant to generate electricity in Ontario. The Board has assigned file number EB-2008-0079 to the application. The Board does not intend to provide for an award of costs when deciding this application.

How to Participate in the Hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant within 10 calendar days of the publication date of this notice.

If you wish to participate in the written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submissions to the Board and one copy to the applicant. All submissions must be received no later than 14 days after the publication date of this Notice. If the applicant wishes to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions no later than 21 days after the publication date of this Notice.

All submissions must quote the file number, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.

Information relating to the application is available for viewing at the Board's offices at the address provided below or by contacting the applicant at the address provided below.
