## NOTICE OF APPLICATION AND HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

### Cambridge and North Dumfries Hydro Inc.

Cambridge and North Dumfries Hydro Inc. ("CND") has applied to the Ontario Energy Board for permission to change its delivery charges beginning May 1, 2013. The application was received on November 12, 2012 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B), under the Board's guidelines for 3<sup>rd</sup> Generation Incentive Regulation Mechanism which provides for a mechanistic and formulaic adjustment to distribution rates between cost of service applications.

Delivery charges are one of four regular items on Residential and General Service customers' electricity bills and vary depending on the amount of electricity consumed. **If the application is approved as applied for, the monthly bill for a Residential customer who consumes 800 kWh per month would decrease by about \$0.33. The monthly bill for a General Service customer consuming 2,000 kWh per month and having a monthly demand of less than 50 kW would decrease by about \$0.53.** The proposed changes to the Delivery charges are separate from other potential changes to the electricity bills, which are not affected by this application.

### **Written Hearing**

The Board intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to a written hearing, you must provide written reasons why you believe an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant within **10 days** of the publication or service date of this notice.

### **How to Participate**

#### **Comment**

If you wish to give your opinion on the proceeding to the Board Members hearing the application, you are invited to send a letter of comment to the Board no later than **30 days** after the publication or service date of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the Hearing Panel.

#### **Observe**

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or service date of this notice.

#### **Personal Information in Letters of Comment and Observer Requests**

All letters of comment or letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's office and will be available on the Board's website. Before placing the letters on the public record, the Board will remove any personal (i.e. not business) contact information from the letters (i.e. the address, fax number, phone number, and e-mail address of the individual).

However, the name of the individual and the content of the letter will become part of the public record. Please address your letter to the Board Secretary at the address below, and reference file number **EB-2012-0111** at the top of your letter.

### **Intervene**

If you wish to actively participate in the proceeding (e.g., submit questions, file argument), you may request intervenor status from the Board no later than **10 days** after the publication or service date of this notice. **The Board does not intend to award costs in this proceeding as the applicant has only made proposals of a mechanistic nature within the Board's guidelines.** Instructions for requesting intervenor status are available on the Board's website at [www.ontarioenergyboard.ca/participate](http://www.ontarioenergyboard.ca/participate). Everything an intervenor files with the Board, including the intervenor's name and contact information, will be placed on the public record, which can be seen at the Board's office and will be available on the Board's website.

### **Interrogatories and Submissions**

Board-approved intervenors or Board staff wishing information and material from CND that is in addition to the evidence filed with the Board and that is relevant to the hearing shall request it by written interrogatories filed with the Board and delivered to CND on or before **December 14, 2012**. CND shall file with the Board complete responses to the interrogatories and deliver them to all intervenors no later than **January 14, 2013**.

Written submissions by an intervenor or Board staff must be filed with the Board, and copied to all other parties, by **January 28, 2013**. If CND wishes to respond to the submissions, its written response must be filed with the Board and delivered to all other parties by **February 11, 2013**.

**IF YOU DO NOT FILE A WRITTEN OBJECTION TO A WRITTEN HEARING OR DO NOT PARTICIPATE IN THE HEARING IN ACCORDANCE WITH THIS NOTICE, THE BOARD MAY PROCEED WITHOUT YOUR PARTICIPATION AND YOU WILL NOT BE ENTITLED TO FURTHER NOTICE IN THE PROCEEDING.**
