Board Staff Comments on Draft Rate Order

On November 8, 2012, the Board issued its Decision and Order (the "Decision") on Veridian's PILs application. The Decision required Veridian to submit a draft Rate Order including a proposed Tariff of Rates and Charges and supporting documentation within seven days of the issuance of the Decision. Veridian submitted its draft Rate Order and supporting documentation on November 16, 2012.

Board staff notes that Veridian has recalculated interest carrying charges to December 31, 2012 for the Veridian, Scugog and Gravenhurst service areas. Board staff accepts Veridian's revised Account 1562 Deferred PILs credit balance of \$189,338 for the Veridian service area; \$1,971 for Scugog; and \$244,857 for the Gravenhurst service area and agrees that Veridian has appropriately reflected the Board's findings in all areas of the Decision.

However, Board staff notes the following in the proposed Tariff of Rates and Charges.

- The proposed rate rider for the disposition of Account 1562 for the Residential Suburban Seasonal rate class within the Gravenhurst service area should be \$-0.0300 per kWh.
- The sunset date should be April 30, 2014 for the Rate Rider for Deferral/Variance Account Disposition (2012) and the Rate Rider for Global Adjustment Sub-Account Disposition (2012) for the Street Lighting rate class in the Gravenhurst service area.
