In response to the email from Martin Benum dated February 28, 2007, the clarification requested for his various notations are as follows:

1. “On Sheet 2 of your 2007 IRM Model, you have entered under Service Classification a reference to “General Service Less Than 50 kw”, and “General Service 50 to 4,999 kw”. A review of your current Board approved Tariff of Rates and Charges shows a Service Classification “General Service Less Than 50 kW, and General Service 50 to 4,999 kW”. There is no reference in your application as to why this description was entered differently to what is on the Board approved tariff sheet. Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation for the omission of this rate class. “

Response: This is a simple transcription error.

2. On Sheet 3 of your 2007 IRM Model, you have entered under Service Classification duplicate descriptions for Residential, and General Service 50 to 4,999 kW. A review of your current Board approved Tariff of Rates and Charges shows singular descriptions for these Service Classification. There is no reference in your application as to why this description was entered differently to what is on the Board approved tariff sheet. Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation for the omission of this rate class.

There is no reference in your application as to why this description was entered differently to what is on the Board approved tariff sheet. Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation of the basis for using this level of charge.

Response: This was a simple transcription error created when the source document (the OEB Rate Order) was scanned and then electronically converted to an Excel compatible format.

4. On Sheet 3 of your 2007 IRM Model, you have entered under General Service 50 to 4,999 kW, Unmetered Scattered Load, Sentinel Lighting, and Street Lighting the reference "Regulated Price Plan". A review of your current Board approved Tariff of Rates and Charges shows that these should read "Regulated Price Plan (if applicable)". There is no reference in your application as to why this description was entered differently to what is on the Board approved tariff sheet. Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation of the basis for using this level of charge.

Response: This was a simple transcription error created when the source document (the OEB Rate Order) was scanned and then electronically converted to an Excel compatible format.

5. On Sheet 3 of your 2007 IRM Model, you have entered under Allowances the reference "Transformer Allowance for Ownership - per KW of billing demand/month". A review of your current Board approved Tariff of Rates and Charges shows that these should read "Transformer Allowance for Ownership - per kW of billing demand/month". There is no reference in your application as to why this description was entered differently to what is on the Board approved tariff sheet. Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation of the basis for using this level of charge

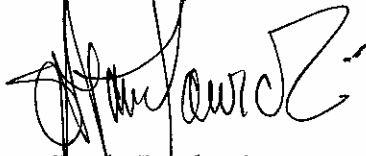

Please clarify whether this was a simple transcription error. If not, please provide a full and complete explanation of the basis for using this level of charge.
