We are retained to act as counsel to Power Workers' Union.

By way of this letter, the Power Workers' Union ("PWU") is requesting Intervenor status in the Board's above-noted proceedings. This matter just recently came to my attention. I note that Procedural Order #1 did not contain a deadline for interventions. However, to the extent this is a late intervention request, the PWU seeks the Board's leave to do so.

The PWU represents the majority of the employees of Hydro One, including employees who would be involved (on behalf of Hydro One) in work in the service territory that is the subject of the application. As a result PWU members will be directly impacted by the application and its outcome.

More generally, the PWU represents a large portion of the employees working in Ontario's electricity industry and has utmost interest in regulatory proceedings that impact the provision of electricity service adequacy, reliability and safety to customers. 
