It has been brought to our attention that, some of the landowners and/or residents along the proposed transmission line of Centennial Road or Hensall Road have not received any notice of the Nextera hearing with the OEB.

Unfortunately, a number of the group individuals either have no computer, have no Internet connection or if they have Internet access were still unable to open the OEB File No. EB-2012-0442.

The group requests 2 hard copies of all the evidence and submissions respecting this application in respect of the Applicant, other Intervenor, and any notices or correspondence, and any amendments to the Application.

We have requested a hard copy of the file that Nextera submitted to the OEB but have not received same to date.

It is noted that Nextera mailed the Registered Mail on Friday December 21, 2012. On December 24, 2012, most of the individual group members received the Notice that they could pick up the registered mail after 18:00 on Christmas Eve, on December 24, 2012. Members of the group could not pick up the Registered Mail until December 27, 2012.
