AND IN THE MATTER OF an Application by Enbridge Gas Distribution for an Order pursuant to Section 90.(1) of the Ontario Energy Board Act, 1998, granting leave to construct a natural gas distribution line and related facilities in the City of Barrie, Township of Springwater in the County of Simcoe.

PROCEDURAL ORDER NO. 1

Enbridge Gas Distribution Inc. ("Enbridge" or "the Applicant") has filed an application with the Ontario Energy Board (the "Board"), received on January 23, 2007, under section 90(1) of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c.15 (Schedule B).

Enbridge has applied for an order of the Board for leave to construct of approximately 20km of NPS 12 XHP main in the city of Barrie to meet the required load growth in the Georgian Bay area. The proposed facilities are located in the City of Barrie, Township of Springwater in the County of Simcoe. The proposed route will be constructed from the Barrie Gate Station to a tie in point intersecting the existing NPS 8 main on Flos Rd 4. The Board has assigned file No. EB-2007-0782 to this application.

Notice of Application for the Leave to Construct Application was served and published as directed by the Board. No intervention requests were received.

The Board has received and approved Nottawasaga Valley Conservation Authority's request for observer status in this proceeding.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

THE BOARD ORDERS THAT:

- 1. Board Staff shall file written interrogatories, if any, with the Board, and delivered to the Applicant on or before Monday April 28, 2008.
- 2. The Applicant shall file with the Board complete responses to the interrogatories no later than Monday May 5, 2008.
