IN THE MATTER OF the *Ontario Energy Board Act 1998*, S.O. 1998, c.15, (Schedule B);

AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. for an order or orders pursuant to section 90 of the Act, granting leave to construct an NPS 8 and NPS 6 natural gas distribution pipelines and ancillary facilities in the Municipality of Clarington in the Region of Durham.

PROCEDURAL ORDER NO. 1

Enbridge Gas Distribution Inc. ("Enbridge") filed an application with the Ontario Energy Board on November 12, 2012 under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B for an order granting Enbridge leave to construct approximately 5.6 km of high pressure ("HP") steel pipeline consisting of two sections, one of Nominal Pipe Size ("NPS") 8 (8 inch diameter; 203 mm) in Bowmanville, Ontario and one section of NPS 6 (6 inch diameter; 152 mm) in Courtice, Ontario to provide distribution services to the Durham York Energy Centre ("DYEC") Facility in Courtice, Ontario. The Board has assigned file number EB-2012-0382 to this application.

The Board issued a Notice of Application dated November 30, 2012.

No party has requested intervenor status in this proceeding.

Observer status was requested by the Regional Municipality of Durham ("Durham"). The Board confirms the observer status of Durham.

The Board considers it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

- 1. Board staff may file written interrogatories with the Board and serve them on Enbridge on or before **February 1, 2013**.
- 2. Enbridge shall file complete interrogatory responses with the Board on or before **February 15, 2013**.
- 3. Board staff may file a written submission with the Board and serve it on Enbridge on or before **March 1, 2013**.
- 4. Enbridge may file a reply submission with the Board on or before **March 15, 2013**.

All filings to the Board must quote file number EB-2012-0382 and be made through the Board's web portal at

https://www.pes.ontarioenergyboard.ca/eservice/, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
