## **Board Staff Comments on Draft Rate Order**

On January 17, 2013, the Board issued its Decision and Order on Midland's rate application. The Decision required the Applicant to submit its Draft Rate Order attaching a proposed Tariff of Rates and Charges within seven days of the issuance of the Decision. The Applicant submitted its Draft Rate Order including a proposed Tariff of Rates and Charges on January 21, 2013. Board staff submits that Midland has appropriately reflected the Board's findings. Board staff however notes below a change in the Application section of the Tariff of Rates and Charges approved by the Board in 2013 rate applications.

## Tariff of Rates and Charges

Board staff notes that the 3<sup>rd</sup> paragraph in the "Application" section of the tariff sheet for each rate class reads as follows:

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.

Based on recent Tariff of Rates and Charges approved by the Board in 2013 rate applications, Board staff submits that this paragraph should be amended as follows:

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable. In addition, the charges in the MONTHLY RATES AND CHARGES – Regulatory Component of this schedule do not apply to a customer that is an embedded wholesale market participant.
