IN THE MATTER OF Approval of the Integrated Power System Plan and Procurement Processes - Board File number EB-2007-0707 – Serpent River First Nation Application for Intervenor Status

I am writing on behalf of the Serpent River First Nation to obtain Intervenor Status for Serpent River First Nation during phase 2 of the Application and Hearing for approval of the Integrated Power System Plan and Procurement Processes.

Description of Intervenor

Serpent River First Nation is a signatory to and beneficiary under the Robinson Huron Treaty of 1850. Our First Nation is located midway between Sault Ste. Marie and Sudbury in the North Channel of Lake Huron. The First Nation's traditional territory extends from the waters of the North Channel of Lake Huron, Serpent River Basin; north beyond the city of Elliot Lake. Serpent River First Nation has a membership of 786 people.

Nature and Scope of Intervenor's Participation

As signatory to the Robinson Huron Treaty of 1850, Serpent River First Nation's membership are the holders of treaty rights, protected under section 35 of the *Constitution Act, 1982*. The Robinson Huron Treaty of 1850 encompasses approximately 6,319,284 ha in Northern Ontario. Our Treaty rights within this area include, but are not limited to hunting, fishing, and trapping. Further, Serpent River First Nation has land claims within the treaty area that are potentially impacted by the issues raised in the proceeding. In addition, Serpent River First Nation has existing and potential power generation activities and opportunities that will be of interest to all parties.

It is respectfully submitted that the extensive scope of the issues raised in the Integrated Power System Plan and Procurement Processes, the potential adverse impact on treaty rights and the recent case law

Our Vision Serpent River First Nation will have self-sufficient people within a community of caring and compassionate families.

Our Mission Serpent River First Nation will use all available financial, human, natural, technological and cultural resources to achieve self-sufficiency through the efforts of all Community Members.
