## PROCEDURAL ORDER NO. 1

Enbridge Gas Distribution Inc. ("Enbridge") filed an application with the Ontario Energy Board on December 11, 2012 under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B for an order granting Enbridge leave to construct approximately 2.8 km of extra high pressure ("XHP") steel pipeline and ancillary facilities along Innes Road in the City of Ottawa, Ontario. The Board has assigned file number EB-2012-0438 to this application.

The Board issued a Notice of Application dated January 9, 2013.

No party has requested intervenor or observer status in this proceeding.

The Board considers it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

## THE BOARD ORDERS THAT:

1. Board staff may file written interrogatories with the Board and serve them on Enbridge on or before **February 15, 2013**.

- 2. Enbridge shall file complete interrogatory responses with the Board on or before **March 1, 2013**.
- 3. Board staff may file a written submission with the Board and serve it on Enbridge on or before **March 15, 2013**.
- Enbridge may file a reply submission with the Board on or before March 29, 2013.

All filings to the Board must quote file number EB-2012-0438 and be made through the Board's web portal at <u>https://www.pes.ontarioenergyboard.ca/eservice/</u>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
