IN THE MATTER OF the Electricity Act, 1998, S.O. 1998, c. 15, Schedule A;

AND IN THE MATTER OF an Application made collectively by entities that have renewable energy supply procurement contracts with the Ontario Power Authority in respect of wind generation facilities for an Order revoking certain amendments to the market rules and referring the amendments back to the Independent Electricity System Operator for further consideration.

We write further to the Board's Procedural Order No. 2 issued on February 4, 2013 in EB-2013-0010 and EB-2013-0029 ("PO2") respecting the Independent Electricity System Operator's ("IESO") January 29, 2013 document production, as amended on January 31, 2013 (the "IESO Production").

It has come to our attention that a document, bates nos. IESO0003476 to IESO0003496, over which the Ontario Power Authority ("OPA") has advised that it intends to assert confidential treatment, has been inadvertently produced. It appears that our service provider embossed two images with the same bates range, resulting in bates nos. IESO0003476 to IESO0003496 being included in the IESO Production in unredacted form. As a result of this error, the IESO requires additional time to re-file its production set, and anticipates that it will be able to do so by tomorrow morning.

As a result of this error, the IESO requests an order of the Board that no person may disseminate, reproduce, refer to or rely on document no. IESO0003476 to IESO0003496, or the information contained therein, until such time as all issues of confidentiality have been determined.

Mr. Vegh has kindly agreed not to disseminate or make further use of the document pending the Board's direction in this matter.

The Board's indulgence regarding the delivery of the revised IESO Production is appreciated.
