1. 2. To arrange immediately for the publication of the French version of the Notice, in the form accompanying this Letter of Direction, including all graphics and the words “Commission de l'énergie de l'Ontario”, in one issue of the French

language newspaper having the highest circulation, according to the best information available, in Chapleau PUC's service area;

Please note that invoices regarding publication are not to be sent to the Board.

3. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Chapleau PUC's previous cost of service rate application proceeding EB-2011-0322 namely;

Vulnerable Energy Consumers Coalition.

4. If Chapleau PUC is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
5. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter;
6. To make a copy of the application and evidence, and any amendments thereto, available for public review at Chapleau PUC's office and on its website;
7. To make a copy of the Notice available for public review at Chapleau PUC's office and on its website; and,
8. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
