# **Compliance Report – January 1 to January 31, 2013**

#### MONTHLY HIGHLIGHTS UPDATE

For the period January 1 - January 31, 2013, Hydro One Networks Inc. (Hydro One) achieved compliance with the terms set out in the Distribution System Code (Code) with respect to the processing in two categories of applications -- applications for indirect connections which do not require a site visit (Group A) and applications for direct connections (Group C). The compliance status for processing applications is shown in "Table 1- Volume of Applications and Compliance Status". There was only one incident of non-compliance with the Code for applications for indirect connections which require a site visit (Group B), but this one incident was compliant with the terms of the exemption.

There were two incidents of non-compliance with respect to physical connections, as shown in "Table 4 – Connection Compliance Status."


