# INTEGRATED GRAIN PROCESSORS CO-OPERATIVE INC. REQUEST FOR ORDER AGAINST NATURAL RESOURSE GAS LTD. PURSUANT TO SECTION 42(3) OF THE ONTARIO ENERGY BOARD ACT, 1998

Integrated Grain Processors Co-operative Inc. ("IGPC") filed an application on October 11, 2012 with the Ontario Energy Board (the "Board") seeking, amongst other things, an order pursuant to section 42(3) of the Ontario Energy Board Act, 1998 (the "Act") requiring NRG to provide gas distribution services and gas sales to meet IGPC's facility expansion and upgrading plans. The application also sought various other forms of relief; however this notice relates only to the section 42(3) issues identified in the application.

IGPC alleges that NRG has refused to discuss IGPC's potential need for additional gas distribution service and gas sales until certain unrelated issues between IGPC and NRG are resolved. IGPC alleges this conduct is prohibited by section 42(2) of the Act.
