**Re: Enbridge Gas Distribution Inc.,
Leave to Construct Application for Alfred and Plantagenet
Board File No.: EB-2007-0745**

Enbridge Gas Distribution ("Enbridge") has received the Notice of Application ("NOA") along with the Letter of Direction ("LOD"), which was issued by the Ontario Energy Board (the "Board") for the EB-2007-0745 Alfred and Plantagenet proceeding.

The title of the NOA issued by the Board indicates that the proposed pipeline is located in the Township of Alfred and Plantagenet and the villages of Alfred, Plantagenet and Wendover in the United Counties of Prescott and Russell.

The villages of Alfred, Plantagenet and Wendover were incorporated into the Township of Alfred and Plantagenet in 1997 and therefore Enbridge believes these locations should be clarified in the NOA. A portion of the Township of Champlain, the geographical area formally known as L'Original should also be listed in the title of the NOA.

Enbridge requests that the NOA be changed to reflect the amalgamation of the villages of Alfred, Plantagenet, and Wendover into the Township of Alfred and Plantagenet and to include the Township of Champlain for the geographical area formerly known as L'Original as described below.

The map that is included with the NOA has been updated to reflect the above noted changes and is included with this letter.

In addition to the changes previously mentioned, Enbridge requests that the following revisions be made to both the English and French Versions of the NOA:

- Change the contact for Enbridge to Patrick Hoey, Director regulatory Affairs;
- On page 1, line 2, eliminate the hyphen; and
- On page 2, line 2, change the NPD to NPS.

With regards to the LOD, Enbridge requests that the LOD be change to direct Enbridge to serve the NOA and the Application on the Clerks of the Township of Alfred and Plantagenet and the Township of Champlain.

Also, in previous LOD's issued by the Board the list of Provincial Government ministries and agencies contained more contacts than those that have been provided in the EB-2007-0745 LOD and it also directed that the NOA be sent to the members of the Ontario Pipeline Coordinating Committee (OPCC). Enbridge requests confirmation from the Board that only the parties listed in the EB-2007-0745 LOD are to be served.
