### NOTICE OF APPLICATION GAS FRANCHISE AGREEMENT AND CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR THE TOWNSHIP OF SOUTH-WEST OXFORD

## UNION GAS LIMITED

On January 23, 2013, Union Gas Limited ("Union") filed an application with the Ontario Energy Board under the *Municipal Franchises Act*, R.S.O. 1990, c. M55, for an order approving the terms and conditions upon which, and the period for which, the Corporation of the Township of South-West Oxford is, by by-law, to grant to Union the right to operate works and add to works for the distribution of gas in the Township of South-West Oxford for a period of 20 years, and for an order declaring and directing that the assent of the municipal electors is not necessary.

Union also applied for an order cancelling and superseding the existing Certificates of Public Convenience and Necessity held by Union for the former municipalities within the Township of South-West Oxford and replacing them with a single Certificate of Public Convenience and Necessity for the amalgamated Corporation of the Township of South-West Oxford except for those areas covered by Certificate of Public Convenience and Necessity E.B.C. 111, 119 held by Natural Resource Gas Limited.

The application has been assigned Board file numbers EB-2013-0020 (regarding the request for a franchise agreement) and EB-2013-0021 (regarding the request for a Certificate of Public Convenience and Necessity).

The application will be decided by the Manager, Natural Gas Applications, who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). The Manager, Natural Gas Applications does not intend to provide for an award of costs when deciding the application.
